

## **Harris/Chicago Bulls Ultimate Fan Contest Official Rules**

1. **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** The odds of winning depend on the sole discretion of the Chicago Bulls fans (the “Fans”), who will be the judges for the Harris Bank/Chicago Bulls Ultimate Fan Monthly Contests (the “Contests”). The Contests are subject to all applicable federal, provincial, state and local laws and regulations. Void where prohibited or restricted by law.
2. **ELIGIBILITY:** The Contests are open only to legal residents residing within 75 miles of the United Center who are 18 years of age or older on the date of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Sponsors (as defined below), the National Basketball Association (the “NBA”), its member teams or any of its affiliates, Chicago Professional Sports Limited Partnership, Chicago Bulls Limited Partnership, and CBLs Corp. and each of their respective parents, subsidiaries, and affiliates are not eligible to participate.
3. **HOW TO ENTER:** There will be six (6) Contests that will be run on the following dates/times (the “Contest Periods”):

Contest #1 - Begins at 9:00 a.m. central time on October 29, 2009, and ends at 9:00 a.m. central time on November 25, 2009. The Prize (as defined below) will be awarded on December 2, 2009.

Contest #2 - Begins at 9:00 a.m. central time on November 25, 2009, and ends at 9:00 a.m. central time on December 22, 2009. The will be awarded on December 29, 2009.

Contest #3 - Begins at 9:00 a.m. central time on December 22, 2009, and ends at 9:00 a.m. central time on January 8, 2010. The Prize will be awarded on January 15, 2010.

Contest #4 - Begins at 9:00 a.m. central time on January 8, 2010, and ends at 9:00 a.m. on central time February 12, 2010. The Prize will be awarded on February 20, 2010.

Contest #5 - Begins at 9:00 a.m. central time on February 12, 2010, and ends at 9:00 a.m. central time on March 18, 2010. The Prize will be awarded on March 25, 2010.

Contest #6 - Begins at 9:00 a.m. central time on March 18, 2010, and ends at 9:00 a.m. central time on April 1, 2010. The Prize will be awarded on April 8, 2010.

Eligible persons may enter the Contests online by accessing [www.bulls.com](http://www.bulls.com) (the “Website”) during each of the Contest Periods. Entrants must accept these Official Rules and thereafter transmit the Entry form. Entrants must submit pictures and videos in accordance with the instructions provided on the Website explaining why they are the ultimate Chicago Bulls fan along with their name, address (including zip code), telephone number (including area code), date of birth and e-mail address (“Entry”). One Entry per person or email address for each Contest. If Sponsors discover multiple Entries from the same person or email address, all such Entries from said person or email address will be void. All required Entry information must be completed in full in order for an Entry to be eligible. Any attempted form of Entry other than as described herein is void. Proof of submission is not proof of receipt by Sponsors.

4. **JUDGING CRITERIA:** The potential winners of the Contests (the “Winners”) will be selected by the Fans from among all eligible Entries received through the Website. There will be one (1) Winner for each of the six Contests. No person can win more than one Contest. The Fans will vote for their favorite Entrant based solely on who they believe to be the ultimate Chicago Bulls fan. The Entrant who receives the most votes will win each Contest. The decisions of the Fans regarding the

determination of the Winners of each Contest is final and binding, and the decisions of the Sponsors, including as to eligibility of Entries, are final and binding on all matters related to the Contests (except for the determination of the Winners).

5. **PRIZES:** One (1) Prize will be awarded for each Contest. Each Winner will receive (i) two (2) 100 level tickets to a Chicago Bulls home game during the 2009-2010 Chicago Bulls season (game will be on the date the Prize for each Contest will be awarded that is designated above) (approximate retail value (“ARV”) of \$260) and (ii) the opportunity to play in the Harris Prepaid Card Shuffle game (“Shuffle”) live on the videoboard from his or her winning seats on the date the Prize will be awarded that is designated above (collectively, the “Prize”). Winner will receive one (1) of three (3) additional Prizes depending on Winner’s selection in the Shuffle. The three (3) additional prizes are: (a) a \$150 Harris debit card (ARV of \$150); (b) a \$100 Harris debit card (ARV of \$100); or (c) a Chicago Bulls foam finger (ARV \$10). The total ARV of the possible Prizes each Winner may receive ranges from \$270 to \$410. If the Harris Prepaid Card Shuffle Prize is not claimed when awarded during the game, the applicable Prize will be forfeited. All costs and expenses associated with the acceptance and use of the Prize not specified herein as being provided, including, but not limited to, lodging, transportation costs, parking, meals, taxes (including income taxes) and gratuities and other expenses incurred by accepting the Prize are the sole responsibility of each Winner. The Prize is non-transferrable and non-assignable, with no cash redemptions or substitutions except at Sponsors’ sole discretion. Sponsors reserve the right to substitute the Prize with a prize of comparable or greater value at their sole discretion. Sponsors, the NBA and its member teams or any of its affiliates, Chicago Professional Sports Limited Partnership, Chicago Bulls Limited Partnership, CBLIS Corp., and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and Contest agencies, and any and all other companies associated with the Contest, and all of their respective equity holders, officers, directors, employees, agents and representatives (collectively, the “Released Parties”) will not be responsible for acts of god, acts of terrorism, civil disturbances, work stoppage or any other natural disaster or circumstances outside their control that may cause the cancellation of any portion of the Prize.
6. **NOTIFICATION:** The potential Winners will be notified by telephone, U.S. Mail, email or overnight courier by the Sponsors. In the event that a Winner does not respond to any such notification within two (2) days of the date of notification, a disqualification will result and, at Sponsors’ sole discretion, an alternate Winner shall be chosen based upon the next highest amount of votes received from among all remaining eligible Entries for such Contest. Each potential Winner will be required to execute and return an affidavit of eligibility and release of liability and publicity, within two (2) days of date of receipt. If all required documents are not properly executed and returned within the specified period of time, a disqualification will result and, at Sponsors’ sole discretion, an alternate Winner will be selected based upon the next highest amount of votes received from among all remaining eligible Entries. Refusal to complete such documents or return of such documents as non-deliverable will also result in disqualification and, at Sponsors’ sole discretion, cause an alternate Winner to be chosen based upon the next highest amount of votes received from among all remaining eligible Entries.
7. **INTERNET ENTRY:** Any Attempt by an individual to deliberately damage the Website or undermine the legitimate operation of the Contests is in violation of criminal and civil laws, and should such attempt be made, Sponsor reserve the right to seek damages from any such individual to the fullest extent permitted by law. None of the Released Parties will be responsible for faulty, incorrect or mistranscribed phone transmissions, incorrect announcements of any kind, technical hardware or software failures of any kind including any injury or damage to any person's computer related to or resulting from participating in or experiencing any materials in connection with the

Contests, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmission that may limit a user's ability to participate in the Contests. Any Entries that are suspected of being fraudulent (including those using robotic, automatic, programmed or similar methods of participation) will be disqualified, based on determinations made solely by Sponsors. Sponsors reserve the right to cancel or modify the Contests if fraud, misconduct or technical failures destroy the integrity of any of the Contests; or if a computer virus, bug, or other technical problem corrupts the administration or security of any of the Contests as determined by Sponsors, in their sole discretion. If technical malfunctions or suspect entries/irregularities corrupt any of the Contests, Sponsors reserve the right, in their sole discretion, to terminate any one of the Contests. In the event of termination of a Contest for any reason, a notice will be posted online and, in Sponsors' sole discretion, the Prize will be awarded from among all eligible non-suspect Entries received prior to termination. Any damage made to the Website will be the responsibility of the authorized email account holder of the email address submitted at the time of Entry. "Authorized email account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization (e.g., business, educational institution etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. Participant may be requested to provide Sponsors with proof that the participant is the authorized email account holder of the email address associated with the account. Sponsors reserve the right to prohibit the participation of an individual if fraud or tampering is suspected or if the account holder fails to comply with any requirement of participation as stated herein or with any provision in these Official Rules.

8. **WAIVER OF LIABILITY/PUBLICITY RELEASE:** By participating in the Contests and submitting an Entry, all participants agree to (i) be bound by these Official Rules, including all Entry requirements and (ii) waive any and all claims against the Released Parties for any injury, damage or loss that may occur, directly or indirectly, in whole or in part, from the participation in the Contests or from the receipt or use of the Prize or any travel or activity related to the receipt or use of the Prize. By acceptance of the Prize, each Winner grants to Sponsors, the National Basketball Association, its member teams or any of its affiliates, Chicago Bulls, Chicago Professional Sports Limited Partnership, Chicago Bulls Limited Partnership, CBLs Corp., and their respective designees the right to publicize such Winner's name, city and state/province of residence and/or likeness in any medium now or hereafter devised worldwide without limitation and without additional compensation or consideration, notification or permission, unless prohibited by law.
9. **HARRIS BANK PRIVACY POLICY:** All personal information collected from the Contests shall be subject to the terms of Harris' Privacy Policy, which may be viewed at [www.harrisbank.com](http://www.harrisbank.com).
10. **GENERAL CONDITIONS:** Released Parties are not responsible for stolen, late, misdirected, lost, damaged, garbled, delayed, incomplete, inaccurate, or illegible Entries. Persons who tamper with or abuse any aspect of the Contests or who are in violation of these Official Rules, as solely determined by Sponsors, will be disqualified and all associated Entries will be void. Sponsors shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Contests, and to resolve all disputes in their sole discretion. The Released Parties (i) make no warranty, guaranty or representation of any kind concerning the Prize, and (ii) disclaim any implied warranty. All disputes will be resolved under applicable U.S. laws in the County of Cook, city of Chicago, State of Illinois. Sponsors reserve the right, in their sole discretion, to cancel or suspend the Contests should unauthorized human intervention or other causes corrupt administration, security, fairness, integrity or proper operation of the Contests.
